CHSA	Consolidated Human Services Agency	An agency that is created when two or more local human services agencies are combined.

DD	Developmental Disabilities	Severe physical, cognitive, and mental impairments that appear before age twenty-two (unless caused by traumatic head injury), are likely to continue indefinitely, and produce substantial functional limitations in three or more of the following major areas of life activities: self-care, learning, mobility, language, capacity for independent living, self- direction, and economic self-sufficiency. Depending on severity, developmental disabilities may include mental retardation, epilepsy, autism, and cerebral palsy. The term also includes delayed cognitive, physical, or communication and social-emotional development in children.
DHD	District Health Department	A local health department that includes more than one county.
DHHS	US Department of Health and Human Services	At the federal level, this department oversees many of the health and human services programs administered in North Carolina. There are several agencies within the department that are responsible for specific programs and areas, such as CMS (Centers for Medicare and Medicaid Services), SAMHSA (Substance Abuse and Mental Health Services Administration), CDC (Centers for Disease Control), and ACF (Administration for Children and Families). http://www.hhs.gov/
	NC Department of Health and Human Services	At the state level, this department oversees most of the health and human services programs administered at the local level. EH services provided by local health departments are designed to protect the public from certain health environmental hazards. Examples include sanitation inspections of restaurants, lodging establishments, and child care facilities, permitting of on-site wastewater systems (septic systems), and regulation of private drinking water wells. EH specialists are the professionals who perform EH services. They must be registered by the state and must be authorized by the state to perform some of the local services.
НА	Hospital Authority	A public body authorized to construct and operate hospitals and other medical facilities in a defined geographic area. In one NC county (Cabarrus), a HA serves as the local health department.
HIPAA	Health Insurance Portability and Accountability Act of 1996 or "HIPAA Privacy Rule"	A federal law that included some requirements related to the privacy of individually identifiable health information. <u>http://www.hhs.gov/ocr/privacy/index.html</u>
LME	Local Management Entity	An area mental health, developmental disabilities, and substance abuse authority (area authority), the entity on the local government level responsible for publicly funded MH, DD, and SA services. An area authority is charged with performing local management entity functions, which include planning, developing, implementing, and monitoring services provided through a network of contracted providers of services.

LME/MCO	Local Management Entity/ Managed Care Organization	A local management entity that is under contract with the NC DHHS to perform managed care organization functions under the combined Medicaid Waiver program authorized under Sections 1915(b) and 1915(c) of the Social Security Act.
LPHA	Local Public Health Agency	A local agency that provides public health services. The term may refer to a county health department, a district health department, a consolidated human services agency that includes public health, a public health authority, or a hospital authority authorized by law to provide the services of a LPHA.
МН	Mental Health	Mental health services provide care and treatment for mental illness. Mental illness covers a group of illnesses, including both emotional and cognitive disorders, characterized by alterations in thinking, mood, or behavior associated with stress or impaired functioning, or both. For children, the common term is "emotional disturbance."
МСО	Managed Care Organization	An organization responsible for managing the cost and quality of health services for a population enrolled with the organization. Area authorities (LMEs) have been approved to perform managed care organization functions for MH/DD/SA services under the State's 1915(b)/(c) Medicaid Waiver.
NCFAST	NC Families Accessing Services through Technology	The state's eligibility and case management system for many social services programs. http://www.ncdhhs.gov/ncfast/index.htm

OSHR	Office of State Human Resources	The state agency responsible for overseeing the state personnel system. Formerly known as the Office of State Personnel, or OSP.

TANF	Temporary Assistance for Needy Families	A federal program that provides temporary financial assistance, employment services, and other social services for low-income families with dependent children. TPR	Termination of Parental Rights	In the child welfare arena, social services officials may ask a court to terminate a parent's rights with respect to a particular child.
1915(b)/(c)	Managed Care Waiver	Refers to two sections of the Social Security Act that allow states to apply for waivers from federal Medicaid policy. Under North Carolina's "(b) Waiver" the state can (1) require Medicaid beneficiaries who seek MH,DD, SA services to enroll with a managed care organization and (2) limit the providers of Medicaid MH,DD, SA services. The "(c) Waiver" provides home and community-based care to Medicaid beneficiaries who would otherwise be institutionalized. Under the state's Medicaid Managed Care Waiver, area authorities (LME/MCOs) operate as managed care organizations for the delivery of MH/DD/SA services.
