This course examines the institutions, processes, and politics of state governments in the United States, with special trends in intergovernmental relations affecting local governments and North Carolina's experiences. Among the topics covered are federalism, constitutional structures and issues, governors, the legislature, state budgets, the judiciary, the bureaucracy, state and local relations, special interest groups, regulatory policy and state politics.

PUBA 749-001 Ethical & Effective Public Administration:

A Capstone Paper Perspective C. Stenberg 0200 – 0450 pm, T 97507 KN 3104

This course will prepare students to conduct their Capstone paper research and manage the process. Sessions will be devoted to organizing and working with the Capstone Committee, identifying a research question, developing and implementing an appropriate research methodology, and presenting research findings and policy implications.

PUBA 768 MEDIATION SKILLS

Theory and practice of dispute resolution and consensus building processes for public policy and program implementation. Utilizes exercises to develop skills in multi-party conflict analysis, negotiation, and intervention for inter-governmental, nonprofit, and community disputes. Workshop-style course focuses on workplace and service provision conflicts to develop mediation skills; is comprised of short lectures, demonstration, and student practice of a mediation model/specific skill sets. **Date/Time:** Fri., Sept. 11, 1-5:30 pm and Sat., Sept. 12, 9-5:00 p.m. (with break for lunch).

PUBA 769 FACILITATION SKILLS

Course is workshop-style that requires preparation via conference call or webinar; separate session on skills; and final requirement is a reflection paper. PUBA 780-002 Public Finance

Develops tools necessary to analyze the impact of public policy on economic agents. Includes analysis of public goods, market failure and deadweight loss of taxation.

PUBA 780-005 Seeking/Securing Grants

Course focuses on the grant seeking process for not-for-profit and public sector agencies, the challenges grant writers confront, and the process of collaborating with outside agencies for mutual benefit. The course will address writing techniques designed to produce proposals that are comprehensive, cogent, and accountable to the objectives of the grantor agency.
