- Bill drafting and review of proposed legislation. Examples include: For NC Conference of Superior Court Judges' Legislative Committee, prepared a paper evaluating the confrontation clause implications of proposed legislation that would adopt a version of the Uniform Child Witness Testimony by Alternative Methods Act; for a District Attorney, reviewed and commented on legislation to create a new criminal offense. Dozens of projects for members of the NC General Assembly and consultations with bill drafting staff, all covered by legislative privilege.
