PETITION TO RESIGN

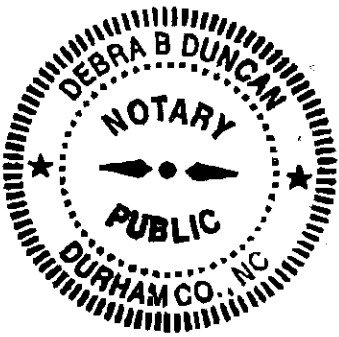
