

- Progressive disciplinary policy:
 Requires "Just Cause"
 I. Personal Conduct
 Unsatisfactory Job Performance
- Grievance Appeal Process
 Obtain a Final Agency Decision (FAD) within 90 days from the date the grevance is filed.
 Contested case may be filed within 30 days of the FAD:
 Discrimination or harassment
 Retailation
 Just cause for dismissal, demotion, or suspension
 Denial of Veteran's Preference
 Failure to post or give priority consideration
 Whistleblower

22% **U**in Employees filing Grievances

In 2017, we had a total of 298 employees file a grievance and a total of **233** in 2018. This reflects a 22% reduction.


19% In Grievances by

Type Filed In 2017, 433 separate grievable issues were filed and a total of **349** in 2018. This reflects a 19% reduction. Grievances based on discrimination were the most frequently filed.

26% **↓** in Grievances continuing to Mediation

In 2017 74% of grievances filed continued to mediation. In 2018 55% of grievances filed continued to mediation.

CHANGES FROM 2017 50% In Agency Settlements In 2017, we had a total of 60 Agency settlements process by OSHR. These totaled to a cost of \$1,630,624.33.

14% Tin University Settlements In 2017, we had a total of 7 University settlements process by OSHR. These totaled to a cost of \$189,574.31.

43% In Total Settlements In 2017, we had a total of 67 settlements process by OSHR.

49% in Total Settlement Cost In 2017, the total settlement cost was \$1,820,198.64.
