Sara DePasquale is the Albert and Gladys Hall Coates Term Professor for Teaching Excellence (2023-2025) at the UNC School of Government. She is an NC Board Certified Child Welfare Law Specialist who teaches, advises, and writes for judicial officials, social services and parent attorneys, and other professionals. Her publication, *Abuse, Neglect, Dependency, and Termination of Parental Rights Proceedings in North Carolina* is an extensive practice manual relied upon by professionals in the court system who are involved in these proceedings.
