*In football, players are taught to give their all **until** the whistle blows, no matter the pain, pressure, or chaos on the field. Doug uses this*

*same principle to inspire public leaders to stay present, empathetic, and intentional until their own “whistle”, the end of the play, the meeting, or the crisis...sounds.*

### **2: Finding the Money: Funding Approaches for Municipal Infrastructure (Winston 3AB)**

Funding the design and construction of infrastructure improvements is a challenge for municipalities regardless of size and annual budget, with projects often postponed or shelved entirely due to lack of available funds. Discretionary and competitive grant opportunities offered by federal, state, and non-profit entities have become increasingly popular, providing the funds needed to complete critical improvements. There are steps that municipalities can take well in advance of funding announcements to compete successfully for these programs. Presenters from the City of High Point and Dewberry will discuss a recent effort to identify strategies for competing for these grants,

including an evaluation of the City's current Capital Improvement Program, a review of current and anticipated funding sources, and identification of pre-application strategies to improve chances of project selection.

**Winston-Salem Innovation Quarter and The Grounds (Wake Forest Stadium District Redevelopment Project)**

*(Registration required)*

Innovation Quarter has recently unveiled a refreshed master plan and new renderings for Phase II, a transformative 28-acre expansion that will elevate the district's role as a hub for life sciences, regenerative medicine, biomanufacturing and community engagement. Since the initial announcement of Phase II in 2021, the Innovation Quarter, created through a public-private partnership, has seen significant expansion and ecosystem development. Anchored by the Wake Forest School of Medicine and supported by Advocate Health, the district now contributes an estimated \$2 billion in annual economic impact, supports 4,000+ full-time employees and generates nearly \$60 million in state and local taxes.

The Grounds is a transformative 100-acre mixed use development in the Deacon Boulevard area (Wake Forest Allegacy

Federal Credit Union Football stadium and Lawrence Joel Veterans Memorial Coliseum), surrounding some of North Carolina's most iconic event venues. Spearheaded by a visionary partnership of Carter, Front Street Capital, Wake Forest University, and the City of Winston-Salem, The Grounds will be a year-round gathering place blending vibrant and unique retail, food and beverage options, entertainment, office, activities, walking trails, and new styles of residential living all in one community hub.
