Why does the Child Support Agency exist?

Because children who have two financially involved parents are less likely to live below the poverty line.



Children who live above the poverty line are less likely to encounter:

- School difficulties and drop-out.
- Joblessness and underemployment.
- Acute or Chronic Mental Health and Behavioral difficulties.
- The Criminal Justice System
- Poor parenting skills that effect their children (generational misery).

As the program expands in ways designed to strengthen families and make them more self-sufficient, the child support program will also continue to strive for right-sized orders and use appropriate enforcement methods to help ensure consistent support payments. Child support attorneys and other child support professionals have important roles to play in this endeavor.

To hold a defendant in civil contempt, the trial court must find the following:



- 1. The order remains in force,
- 2. the purpose of the order may still be served by compliance,
- 3. the non-compliance was willful, and
- 4. the non-complying party is able to comply with the order or is able to take reasonable measures to comply.


IV-D Child Support Court - Per Statutes

Purpose of Article 9, N.C.G.S. §110-128 – §110-150

"The purposes of this Article are to provide for the financial support of dependent children ..."

Providing for the welfare of children: different from criminal law different from private family court.

"The Defendant shall keep the Durham County Child Support Office informed at all times of the Defendant's current residence, mailing address, name and address of any payor of disposable income, effective date of any substantial changes in disposable income, and shall cooperate fully in verifying the amount of the Defendant's disposable income."
