<u> Telephone & Internet</u>

- The hotel has offered us free Wi-Fi in your hotel rooms.
- If you do not have the Google Maps app on your cell phone, you may want to download it to assist with navigation in the city.

Transportation in the City

- Most of the activities we will be participating in will be within a 15 minute walk of the hotel. We are hoping that everyone will join us for the walk. Walking directions are included on the agenda below.
- If you prefer not to walk, you can take the Metro. There are two stations near the hotel, both on the Red Line Union Station and Judiciary Square Station. Unfortunately, most of our destinations are not on the Red Line and it would often take you twice the time to use the Metro or Bus. If you would like to use the Metro, you may want to download the Metro app to your phone to assist with your navigation.
- If you prefer not to walk, you can also use Uber. If you have not used Uber before, you will want to download the app on your phone and create an account in advance. It appears that the average fare for Uber from our hotel to any of the locations can run from \$6 to \$20 a trip.



## Walking Directions: Hotel to US Supreme Court (1 First Street NE)

- Turn left out of hotel onto New Jersey Ave NW toward D St NW
- Go about 3 blocks and turn left onto Constitution Ave NW
- Go about 2 blocks and turn right onto First St NE



## 8:30am Arrive at U.S. Supreme Court

- No electronics (cell phones, cameras, etc.) or personal items (coats, books, bags, etc.) are allowed in the Courtroom. We will be able to leave our belongings in an assigned meeting room during the arguments.



- Turn left onto D St NW

- Cross over Columbus Circle and Union Station Dr NE

- Go 1 ½ blocks and turn right onto Constitution Ave NW




- Security to enter the National Archives could take an hour to complete.

- Meet at the statue of Astronaut Jack Swigert which will be the last statue you see.

To find the astronaut, please enter the Capitol Visitors Center, proceed through security screening and then enter the Capitol Visitors Center. Once in the Capitol Visitors Center walk down the center stairs and turn to your left once you reach the bottom. The astronaut will be the last statue you see.



#### Walking Directions: Hotel to U.S. Holocaust Museum

- Turn left out of the hotel onto New Jersey Ave NW toward D St NW
- Go 2 blocks and turn right onto Louisiana Ave NW
- Go about 2 blocks and continue right onto Constitution Ave NW
- Stay on Constitution Ave NW/Pennsylvania Ave NW and then keep left to stay on Constitution Ave NW
- Turn left at 7<sup>th</sup> St NW and cut through the National Mall
- Turn right onto Jefferson SW in front of the Smithsonian Castle onto Jefferson Dr SW
- Turn left onto 15 St SW/Raol Wallenberg PI SW

William F. Meinecke, Jr., PhD

Dr. William Meinecke is a historian for the Museum's leadership development programs and is the author of *Nazi Ideology and the Holocaust*, published by the Museum in 2007. He joined the Museum's staff in 1992 to help create the *Historical Atlas of the Holocaust* and a multimedia learning site for students. A graduate of the University of Maryland, Baltimore County, he also attended the Universities of Bonn and Berlin in Germany and received an MA and a PhD in history from the University of Maryland at College Park. His dissertation is titled "Conflicting Loyalties: The Supreme Court in Weimar and Nazi Germany, 1918– 1945."
