Judicial Branch Mission Statement:



 identify areas of concern and take action.






Pending Driving while Impaired Cases




- How is the North Carolina Judicial Branch performing?




Time to Case Disposition




Improvement is Possible in North Carolina

RECENT LEGISLATION IMPACTING MAGISTRATES

- House Bill 243, Section 8.4. Approved by the General Assembly on March 10, 2022.
- Not yet signed into law by the Governor.
- A technical corrections bill with a retroactive effective date of July 1, 2021.

ALLOW MAGISTRATES TO PERFORM CRIMINAL FIRST APPEARANCES UNDER CERTAIN CIRCUMSTANCES SECTION 84. G.S. 15A-601(e) reads as rewritten: "(e) The clerk of the superior court in the county in which the defendant is taken into custody may conduct a first appearance as provided in this Article if a district court judge is not available in the county within 72 hours after the defendant is taken into custody or 96 hours after the defendant is taken into custody if the courthouse is closed for transactions for a period longer than 72 hours. A magistrate may conduct the first appearance if the clerk is not available. The eleft, eleft, or magistrate, in conducting a first appearance, shall proceed under this Article as would a district court judge."
