



## KNOW YOUR RIGHTS IN NC PUBLIC SCHOOLS!

- Students have a right to enroll in public school if they meet certain requirements.
- Parents/guardians and eligible students (i.e., students age 18 and older) have a right to review student education records and challenge incorrect information.
- Students who are failing or at risk of academic failure have a right to a Personal Education Plan (PEP) that includes a diagnostic evaluation, interventions (e.g., tutoring, Saturday school, and smaller classes), and progress monitoring strategies.
- Students who have a disability and need special education have a right to an Individualized Education Program (IEP) and a free and appropriate public education (including during long-term suspension) in the least restrictive environment (i.e., with non-disabled peers to the greatest extent possible).
- Students facing short-term suspension (one to 10 school days) have a right to notice and an opportunity to tell their side of the story, take textbooks home, get missed assignments, and make up exams.
- Students have a right to be free from bullying.



- Students facing long-term suspension (11 school days or more) have a right to: written notice; review evidence against them; have a hearing before an unbiased decision-maker where they can bring an attorney, present evidence and witnesses, cross-examine witnesses against them, and make a recording; appeal to the local board of education; appeal to the local superior court; and be offered alternative education, unless the school district has an important reason not to offer it.
- Students have a right to be free from self-incrimination (i.e. protections during interrogations), unreasonable search and seizure, and excessive force.
- Students have a right to be free from discrimination based on race, national origin (including being denied translation/ interpretation), sex, age, and disability.

## WHAT CAN LEGAL AID OF NORTH CAROLINA DO FOR YOU?

#### LEGAL REPRESENTATION

LANC attorneys provide high-quality, free legal advice and representation for students who are:

- from low-income families or in foster care; and
- 2. U.S. citizens or refugees.

LANC attorneys assist in matters such as:

- Enrollment
- Academic failure
- Special education
- Suspension and expulsion
- Transfers to alternative school
- Bullying
- Discrimination
- Mistreatment by school security personnel

LANC does not handle child support, custody, divorce, or criminal matters.

### **COMMUNITY EDUCATION**

LANC also provides:

- Presentations and trainings for students, parents, service providers, advocates, educators, and other concerned citizens
- Publications, such as fact sheets, issue briefs, and self-help guides
- Media outreach, such as press releases, interviews, letters to the editor, and op-eds
