






- *Shortened Early Voting Period but more hours
- *Notification of Photo ID Requirement
- *Photo ID in 2016
- *No Straight-Party Ticket Voting
- *In-precinct Voting; Unreported Moves
- *Absentee Ballot NO photo ID needed; 2 Witnesses
- *MAT Teams assist voters in facilities and can witness
- *SDR & Pre-Registration Eliminated; 25 day prior to general election

*2014 Election Law Changes

- *A North Carolina driver license, including a learner's permit or a provisional license OR A special DMV issued identification card for non-operators.
- *U.S. Passport
- * U.S. Military Identification Card Active and retired.
- *U.S. Veterans Identification card issued by the Department of Veterans Affairs for use at Veterans Administration medical facilities
- *Tribal enrollment card issued by a federally-recognized tribe
- *Tribal enrollment card issued by a NC-recognized tribe, signed by an elected official and complaint with G.S. 163-166.13
- *Out-of-state driver's license or non-operator's identification card (BUT only if the voter registration date is within 90 days of the election)

*HOW CAN YOU HELP?

- *No registered voter will be turned away from the polls or not allowed to vote.
- ${\bf *Absentee\ voting}.$
- * Register 25 days prior to election.
- *10 days of early voting.
- *Vote in-precinct on election day.
