## 9:00 a.m. – 12:00 p.m. Mobile Workshop. Tour of the Winston-Salem Police Department's "Real Time Crime Center" (Salem 1AB)

Please note: The Real Time Crime Center is located approximately 0.3 miles or 2 blocks from the Convention Center. Participants will be expected to walk to/from the convention center and Real Time Crime Center.

The Winston-Salem Police Department's Real Time Crime Center (RTCC) serves as a centralized hub of realtime information, providing the department with the ability to use technology and other resources to support intelligence-led policing efforts that increase the safety of police officers and citizens alike. Technological components in the RTCC include a community connect camera-sharing program and camera registry; a text-atip line that accepts text, photo, and videos; and the ShotSpotter gunfire detection system. Money for the center came from a \$700,000 U.S. Department of Justice/Bureau of Justice Smart Policing Assistance grant. The Winston-Salem Police Department was one of ten agencies nationwide to receive the funding, and the center is one of the first of its kind in the region.
