THE PROJECTED COSTS OF DOING NOTHING

ON AVERAGE, FOR EVERY YOUNG PERSON WHO AGES OUT, TAXPAYERS AND COMMUNITIES PAY \$300,000 IN SOCIAL COSTS OVER THAT PERSON'S LIFETIME.

Social costs equal taxpayer-funded costs such as **public assistance** and **incarceration**, as well as costs **absorbed by the community**, such as wages lost as a result of dropping out of high school.

Careful and sensible parental decisions



Health, safety, best interests Encourage emotional & developmental growth

Age/Developmentally Appropriate Activities

Appropriate based on cognitive, emotional, physical, & behavioral capacities typical for an age/age group

Suitable for child same age/maturity



DSS Makes Decisions generally made by custodian unless prohibited by federal law

Court <u>shall inquire</u>

- Whether teen has copies of documents
 - Birth certificate, social security card
 - Health insurance information
 - Driver's license/other ID
 - Education/medical/other records requested by juvenile
 - Participation in Foster Care 18-21

Identify person/agency assist teen in obtaining the documents

Federal law starting at 14 y.o.

Annual copy of any consumer report for child

Receives assistance interpreting and correcting



DSS report to the court

- Efforts to identify/secure viable placement at 18
- List of adult resources for when 18
- Contact info re: Foster Care 18-21
- If appropriate, info about how to maintain contact with family when turn 17
- A point of contact for Medicaid and maintaining physical/mental health services provided when 18
- Info about educational, vocational or jobs plans for when 18

APPLA, G.S. 7B-912(c), (d)

Findings of each before plan ordered

16 or 17 years old

- DSS made diligent efforts to permanently place w/parent or relative, guardianship, or adoption
- Compelling reasons exist that not in BIC to place permanently w/ ...
- APPLA is best permanent plan
- If approved, after <u>questioning teen</u>, the teen's desired permanency outcome

A SOLVABLE PROBLEM

Despite these realities, there are reasons for optimism. Through a law passed in 2008³, the federal government offers a financial incentive to states that choose to extend foster care services for young people beyond age 18.

Termination of agreement

DSS must go to court if young adult objects

Protocol – What you must do	Guidance
Foster Care 18 to 21 is a program that offers young adults opportunities to continue foster care placement and transition to independence with county child welfare agency supervision. There are some young adults who may not be ready to exit foster care upon turning 18 years of age, and may choose to stay in Foster Care 18 to 21 as long as certain requirements are met. Young adults who exit foster care at age 18 are also able to return to the Foster Care 18 to 21 program at a later date as long as they have not reached their 21 st birthday.
