




Just enter your words and connectors in the red search box, e.g., same sex! W/10 marriage, and click Search. Lexis Advance automatically interprets search commands—! and * to truncate words and W/n, OR, AND, etc.

Please note: Lexis Advance ignores certain "noise words" in your query but counts these noise words when determining the proximity of terms in a document. So, broaden your proximity connectors. For example, consider searching W/10 instead of W/5. For W/p and W/s, consider W/75 or W/25, respectively.


Note: Only the AND connector works in Lexis® Web.





It's simple! Enter a partial **source name** in the **red search box**. The word wheel will make suggestions. OR ...

- 1. Click Browse Sources (above the red search box).
- 2. Enter a partial title in the Sources search box. (Or browse titles alphabetically, by content type[s] or jurisdiction[s].)
- 3. Click a title link. Select an action, e.g., Add the source to a search. (Also save the source to your favorites list or view a source description, e.g., update schedule, content, etc.)



To combine sources:

- Enter a partial source name in the red search box.
 The word wheel will make suggestions. Select a source.
- Repeat to add more sources to your search. The source combination is saved automatically in Recent & Favorites.Click Recent & Favorites under the red search bar to reuse.

To create and search favorite sources:

- · Click Recent & Favorites under the red search bar.
- Click the gold star next to a source to make it a favorite, i.e., keep it on the list.

Note: Your sources stay selected to search until you click **Clear All.**

 Use a number with ATLEAST. Use OR or AND only.

Use connectors with segment searches. Review the available segments for each content type.






Enter the **citation(s)** in the red search box and click **Search**. For example, ENTER:

You receive **two** results tabs:

- 1. The red case-name tab offers the **full text** of the case. (Find links to the documents if you entered multiple citations.)
- 2. The citation tab includes **results that reference** your citation. (If you entered multiple citations, results will reference one or more cites.)



The Lexis Advance word wheel contains the names and citations of the **5,000 top-cited cases** and many U.S. Public Laws and popular state laws. If you begin to enter party names or a statute name, the word wheel will make suggestions.



Also find cases by searching with the NAME segment.

Enter: NAME (roe and wade)




Browse or search a table of contents (TOC)

TOCs are available for U.S. and state statutes, constitutions, court rules and administrative codes, plus municipal codes and many treatises, guides and form books.

Gain access to a TOC several ways:

- Enter the TOC source name in the word wheel and select the View Table of Contents link.
- 2. Identify your TOC source in Browse Sources and select the View Table of Contents link.



- **3.** Select the source's **View Table of Contents** link in your search results.
- **4.** Select the source's **View Table of Contents** link in your Recent & Favorites list.

To browse a TOC:

Open and close hierarchy levels. Click ▶ to open, ▼ to close.

Click a **blue document link** to open a full-text section. The document opens in a new tab. To return to the TOC, close the document tab.

To search a TOC:

Enter your search terms in the search box at the top of the open TOC, e.g., ENTER: *electronic /5 filing*.


You can search:

- Both the TOC and documents at once, or the TOC or documents separately. Make your selection next to the Search button. (Default is both.)
- Specific portions of the TOC, e.g., several chapters.
 Click the magnifying glass icon next to the sections you wish to search.


After you make your selections, click Search.

Open relevant documents or browse surrounding levels. To return to the TOC, click the document name link or click on the TOC tab.






Move to preceding or succeeding sections. Click the Next or Previous arrows at the top or bottom of the screens. Or move to a TOC level: Select a level from the hierarchical links.



Click **Browse Topics** (above the red search box). You can search for your topic or browse a topic hierarchy.



To search for your topic:

Enter your search words in the topics search box, e.g., exculpatory clauses, and click **Search**.

To browse for your topic:

- 1. Select an area of law, e.g., Contracts Law.
- 2. Click ▶ to open subtopics, ▼ to close.
- 3. Click a topic link. Select a task.

HN Use LexisNexis® headnotes to find documents

Find the LexisNexis headnote you want to explore in a full-text case



- 1. Click a topic link in the headnote, e.g., Elements of Contract Claims
- 2. Click **Get topic documents**. Your results documents are sorted by relevance with the Cases tab displaying.
- 3. Refine. Add filters, e.g., select a jurisdiction. Or Search within results, i.e., add search words to describe your issue or fact pattern.



Refine your search results

Refine by adding search words

- 1. Go to the Search within results search box at the top left of your results screen.
- 2. Enter your search terms, e.g., ENTER: shock! W/5 conscience W/5 standard and click **OK**.

To remove the additional search words, click the X next to the displayed words.

Refine by filters

You can filter only one content type, e.g., cases, at a time.

Click a filter link to apply it to your results. All filters added display at the top of the filter list on the left.

Click the X next to the filter at the top of the filter list to remove it. To remove all filters, click Clear All.

Add citations: Including parallel cites and links to the full-text document. Just click the Copy Citation link at the top of the full-text document.

Print, email, download and save to work folders

Deliver a single document as you view the full text of that document. Deliver one or more documents from the results. list-even across tabs. Click the checkbox next to each document you wish to deliver.

Then look for the delivery icons at the top of the screen:



Print: Options let you open as a PDF, format (fonts, search terms in bold, etc.), show headnotes in cases, etc.



Email: Options let you format, add recipient addresses, subject and message.



Download: Options let you download as DOCX or PDF, send to LexisNexis® CaseMap® case analysis software or download the results list. Even send as multiple, zipped files.



Save to a work folder: Options help you select a folder, save the document(s) or results list(s) and add notes to preface the document(s).



Open results documents in a browser window

Right-click on a document link in your results. Select Open in new window. This option helps keep the tabs on your Lexis Advance screen at a minimum.
