Dear Judge Costanzo:

Thank you for speaking with me yesterday in the above-referenced matter. This letter is to document our communication regarding jurisdiction as required by the UCCJEA.

Ms. was present in North Carolina on December 9, 2020 seeking Expedited Enforcement of a Foreign Order (Connecticut) and emergency pick up of the minor child:

Because you also have a pending custody action in Kings County, New York, we were required to communicate about the simultaneous actions. I am also aware that action for protection of the same child in Pennsylvania on December 8, 2020.

After communicating with you, I understand that there is a New York custody order in place that gives Mr. of the minor child was also and Ms. is only permitted supervised visitations. This Order was entered in 2020, after the Connecticut Order was entered in 2017.

As we discussed, I am confused about the residences of all these parties and whether the child i			
actually in North Carolina. Ms. has listed multiple addresses for herself, the child,			
and the Defendants in various pleadings filed here in the last two weeks. I denied Ms.			
petition because the Connecticut Order she was seeking to enforce is no longer the			
controlling custody order. The Defendants in my case (			
been served yet and were not present, but I summarily denied the petition.
