COME NOW Plaintiffs John Rouse, in his capacity as Health Director for the County of Harnett and County of Harnett (hereinafter collectively referred to as "Plaintiffs"), complaining of Defendants H & H Commercial Properties, LLC and Jerry M. Hartman (hereinafter collectively referred to as "Defendants"), and alleging as follows:

PARTIES

1. Plaintiff John Rouse (hereinafter referred to as "Plaintiff Rouse") is the duly qualified and acting health director of the County of Harnett, and as such is "a local health director" within the meaning of Chapter 130A of the North Carolina General Statutes.
2. Plaintiff County of Harnett (hereinafter referred to as "Plaintiff County") is a body politic, duly organized and existing under the laws of the State of North Carolina.
3. Upon information and belief, Defendant H & H Commercial Properties, LLC (hereinafter referred to as "Defendant H & H") is a limited liability company organized and existing under the laws of the State of North Carolina. Upon further information and belief, on or about January 14, 2016, the Office of Secretary of State, State of North Carolina administratively dissolved Defendant H & H.

4. Upon information and belief, Defendant Jerry M. Hartman (hereinafter referred to as “Defendant Hartman”) is a citizen and resident of Harnett County, North Carolina.

5. Upon information and belief, Defendant Hartman is and was the manager and registered agent of Defendant H & H.

JURISDICTION AND VENUE

6. Jurisdiction and venue of this matter are proper pursuant to §§ 1-75.4, 7A-240, 7A-243, and 130A-18 of the North Carolina General Statutes.

FACTS

7. Defendant H & H is the record owner of a 14.2 acre parcel of land located at 151 Sensation Lane, Dunn, Harnett County, North Carolina, Parcel Identification Number 021517 0181, Property Identification Number 1527-02-3365.000 (hereinafter referred to as “the Parcel”). Please see Harnett County GIS records and General Warranty Deed, attached hereto as Exhibits A1 and A2, respectively.

8. The parcel contained a candy factory many years ago, prior to the ownership of Defendant H & H. However, the building housing the candy factory burned, and upon information and belief, a shell of the building remains but has not been renovated or remediated subsequent to the fire.

9. The parcel contains no other improvements, and is thus open land with some cleared areas and some wooded areas.

10. The back end of the parcel abuts a residential subdivision within the city limits of Dunn, Harnett County, North Carolina (hereinafter referred to as “Dunn”) with at least 100 single family homes (Lakeside Village Subdivision), and there is a recorded easement of ingress and egress between the subdivision and the Parcel. Please see Exhibit A1 and A2.

11. On or about January 27, 2016 at 2:00 p.m., Defendant Hartman and his son met with officials from Dunn, including the Director of Planning and Zoning, Samantha Wullenwaber, the Fire Marshal, Anthony Haney, and the Chief Building Inspector, Steven King. Defendant Hartman initially requested permission to hold a "fire show" on the Parcel, then later stated that the proposed event would be an arts festival, then later stated that the proposed event would be a music festival, and then finally stated that the proposed event would be a three day arts and music festival with primitive camping, fire shows, vendors, alcohol, musicians, and the like (hereinafter referred to as "the Proposed Event"). Please see Affidavit of Samantha Wullenwaber, attached hereto as Exhibit B.

12. Ms. Wullenwaber, along with her other colleagues in attendance at the meeting, unequivocally advised Defendant Hartman that such event would be in violation of the Dunn's zoning ordinance, in that the parcel is currently zoned "industrial," and cannot be used to hold such commercial events.

13. At this January 27, 2016 meeting, Ms. Wullenwaber further advised Defendant Hartman that he could apply for the Parcel to be rezoned to "commercial," and then further apply for a conditional use permit for an event venue. Defendant Hartman responded that he did not wish to apply for rezoning, or for a conditional use permit.

14. In response to Defendant Hartman's statement that he did not wish to seek the proper zoning and use permits, Ms. Wullenwaber unequivocally advised Defendant Hartman that the Proposed Event could not happen at all, no matter how big or small, due to not only the zoning issues herein referenced but also due to concerns over fire and building code violations that would most likely occur if the Proposed Event went forward.

15. The Parcel is within the extra-territorial jurisdiction of Dunn, and thus enforcement of State fire and building codes is delegated to Dunn officials.

16. Ms. Wullenwaber heard nothing further from Defendant Hartman, and nothing further regarding this proposed event, until on or about February 5, 2016. On that day, Ms. Wullenwaber received a telephone call from Sharon Stevens, the Dunn Tourism Director, in which Ms. Stevens advised Ms. Wullenwaber that “a big festival” was set to occur in Dunn February 19 through 21, 2016. When Ms. Wullenwaber questioned Ms. Stevens further, it became apparent to Ms. Wullenwaber that the event to which Ms. Stevens was referring was the Proposed Event Ms. Wullenwaber previously advised Defendant Hartman that he could not have.

17. Ms. Wullenwaber then found a Facebook page promoting the Proposed Event, and denominating it as the Candy Music and Arts Festival. Please see entire copy of Facebook page concerning the Candy Music and Arts Festival, printed as of February 17-18, 2016, attached hereto as Exhibit C.

18. According to Exhibit C, 11,000 people have been extended electronic invitations to attend the Proposed Event, almost 500 people indicate that they will be attending the Proposed Event, and almost 900 people state that they are interested in attending the Proposed Event. Moreover, Exhibit C indicates that “memberships” (tickets) may be purchased in advance for \$20.00, or purchased at the door for \$25.00.

19. The Proposed Event also has its own promotional website, in which it states that the Proposed Event will be held on 15 acres with two stages, and will include fire shows, approximately 35 music groups, camping, and the like. The website further states that attendees should bring “camping gear, food and clothing for two days, flow toys and enough energy to rage,” and to contact Meli Markham “[i]f you wish to burn any time during the event.” Please see copy of Candy Musical/Fire/Art Festival web page, attached hereto as Exhibit D.

20. *The Fayetteville Observer* newspaper ran an article on the Proposed Event on February 18, 2016 in which it states the following:

This weekend, the biggest party around is in the last place you'd think to look – on 15 overgrown acres on the outskirts of Dunn. The Candy Music and Arts Festival is bringing more than 50 musicians and dozens of dancers, fire performers, live artists, food trucks and vendors for three days and two nights... Primitive camping is included for ages 18 and older – tarps and bottled water are recommended. Please see copy of *The Fayetteville Observer* newspaper article dated February 18, 2016, attached hereto as Exhibit E.

21. Since late January 2016, hundreds of people have commented on the Facebook page dedicated to the Proposed Event. Included within the comments section of this page are the following publicly disseminated statements dated February 9, 2016:

The Initiative Arts Collective – The event IS on private property, owned by the family of one of the organizers. **The land is actually zoned for industrial use, and although there are developments within a few miles – most of which are still under construction – they have been accounted for when planning sound direction. Both the local and country [sic] governances [sic] have been made aware of the event and have visited the property to issue the proper permitting....**

Michael Alexander Patrick – Thank you for making that clear....

R. Evan Price – Its [sic] far enough away from residential. This is officially a membership based event, not ticketed due to zoning issues we hope to have resolved by next time. **The city of dunn [sic] has kind of given their blessing with that stipulation and the county officially does not care. We called and asked.** Emphasis added. Please see a copy of this commentary taken from the Facebook page at issue, attached hereto as Exhibit F.

22. The above-referenced statements are **complete misstatements of fact**, and have now been disseminated throughout the internet. Subsequent to the above-referenced misstatements of fact, hundreds of people purchased tickets, relying upon these misstatements to be true.

23. Plaintiffs did not become aware of the Proposed Event until approximately 11:00 a.m. on Wednesday, February 17, 2016, and at no time have Plaintiffs given any sort of indication, whether direct or indirect, that they approve of or condone the Proposed Event.

Other comments on the Facebook page promoting the Proposed Event discuss burning or fire activities anticipated to occur, including burning hoops, burning numb chucks, and one individual who offers to set her hair on fire and whip her head around. Please see a copy of this commentary taken from the Facebook page at issue, attached hereto as Exhibit G.

24. Another comment on the Facebook page promoting the Proposed Event and dated February 9, 2016 has a link to visit if one is interested in either being a food or other vendor or volunteering to work at the Proposed Event. The actual volunteer application the link directs one to purports to actively recruit volunteers for the following positions: paramedic; medical tent assistant; front gate attendant; parking lot attendant; security/peacekeeper; fire tender; personal assistant; photographer; videographer; and live artist. The application states that “[t]he existence of a criminal record DOES NOT disqualify you as a volunteer, but may affect which position(s) you are assigned.” There is no requirement to hold any sort of licensures or certifications, nor does a clean criminal record appear to be required, to hold positions related to public safety, security, medical treatment, and fire tending. Please see a copy of this commentary dated February 9, 2016 and taken from the Facebook page at issue, attached hereto as Exhibit H.

FIRST CLAIM FOR RELIEF – UNPERMITTED MASS GATHERING

25. The preceding paragraphs to this Complaint are incorporated by reference as if fully set forth herein.

26. Section 130A-18 of the North Carolina General Statutes provides in part that if a person shall violate any provision of Chapter 130A of the North Carolina General Statutes, or the rules adopted by the Commission for Health Services, or the rules adopted by a local board of health, the Secretary of Health and Human Services, or a local health director may institute an action for injunctive relief, irrespective of all other remedies at law, in the Superior Court of the County where the violation occurred or may occur, or where a defendant resides.

27. Plaintiffs bring this action to enforce the provisions of, *inter alia*, Article 8, Part 7 of Chapter 130A of the North Carolina General Statutes, the Mass Gathering Statute, including the rules and regulations promulgated thereunder, and to otherwise enjoin conduct in direct violation of said statute.

28. Section 130A-253(a) of the North Carolina General Statutes provides, in pertinent part, that “[n]o person shall organize, sponsor or hold any mass gathering unless a permit has been issued to the person by the Secretary under the provisions of this Part.”

29. Pursuant to §130A-227(b)(2) of the North Carolina General Statutes, “Secretary” is defined as the Secretary of the North Carolina Department of Health and Human Services.

30. Pursuant to §130A-252(a) of the North Carolina General Statutes, “mass gathering” is defined as “a congregation or assembly of more than 5,000 people in an open space or open air for a period of more than 24 hours... organized or held for any purpose...”

31. Pursuant to §130A-252(a) of the North Carolina General Statutes, the longevity of the gathering, for purposes of determining whether the gathering meets the statutory definition of a mass gathering, “the period shall begin when the people expected to attend are first permitted on the land where the congregation or assembly will be held and shall end when the people in attendance are expected to depart.”

32. To determine whether a gathering meets the statutory definition of mass gathering with respect to the number of people in attendance, §130A-252(a) of the North Carolina General Statutes permits the calculation to consist of “the number reasonably expected to attend, as determined from the promotion, advertisement and preparation for the congregation or assembly.”

33. North Carolina General Statute §130A-257 of the North Carolina General Statutes requires the establishment of rules to carry out the provisions of the Mass Gathering Statute, and

“to establish requirements for the provision of facilities and services at mass gatherings,” which shall include, but not be limited to, general requirements relating to:

- a. Minimum size of activity area, including camping and parking space, distance of activity area from dwellings, distance from public water supplies, and an adequate command post for use by personnel of health, law enforcement, and other government agencies;
- b. Adequate ingress and egress roads, parking facilities, and entrances and exits to public highways;
- c. Plans for limiting attendance and crowd control, dust control, and rapid emergency evacuation;
- d. Medical care, including facilities, services, and personnel;
- e. Sanitary water supply, source, and distribution; toilet facilities; sewage disposal; solid waste collection and disposal; food dispensing; insect and rodent control; and post-gathering clean-up; and
- f. Noise level, lighting, and signs.

34. The rules promulgated pursuant to §130A-257 of the North Carolina General Statutes are found at 15A NCAC 18A.1404 through .1425, and include specific requirements, including, but not limited to the following:

- a. An activity area shall be provided of sufficient size to accommodate the estimated number of persons reasonably expected to be in attendance at any one time. This activity area is in addition to those areas required for parking, camping, and for a command post (15A NCAC 18A.1404);
- b. An area of adequate size to accommodate the provision of safe drinking water and sewage collection and disposal shall be provided and designated

for camping, and shall be in addition to the areas provided for the main event itself and for parking (15A NCAC 18A.1407);

- c. A command post at a conveniently accessible location approved by the Department of Health and Human Services shall be provided for use by the Department, law enforcement, and other governmental agencies with regulatory authority for such events, and shall consist of at least one building or mobile unit equipped with telephones, other utilities, and parking space, and in addition shall provide access to the command post at all times for use by the Department and other governmental entities (15A NCAC 18A.1408);
- d. Personnel and arrangements necessary to keep entrances and exits to public highways open to traffic at all times shall be provided, and arrangements shall be made with private parties or the North Carolina Department of Transportation and Highway Safety regarding adequate ingress and egress roads (15A NCAC 18A.1409);
- e. Parking spaces shall be provided on the basis of one space for every four persons expected to attend, vehicles used for camping shall park in the required camping area, parking on shoulders of public highways shall not be permitted, and temporary signs shall be erected to so indicate (15A NCAC 18A.1410);
- f. A written plan for limiting attendance to the number stated in the application for permit, the exclusion of persons not holding tickets, and for security enforcement, including the number of security guards to be provided for internal and external crowd control and security enforcement

- shall be accompanied by a written statement by the sheriff or chief of police, whichever has jurisdiction over the area, that the plan seems adequate (15A NCAC 18A.1411);
- g. A written plan for fire prevention and control shall be submitted (15A NCAC 18A.1413);
 - h. A written plans for dealing with emergency situations involving the occurrence of incidents requiring rapid evacuation, including arrangements for use of emergency egress roads, shall be submitted (15A NCAC 18A.1414);
 - i. A written plan for the provision of medical care, approved in writing by the local health director, and including provisions for:
 - (1) The name and address of a physician licensed to practice medicine in North Carolina to be responsible for the organization and delivery of emergency medical services, along with a signed notarized statement by the physician accepting such responsibility;
 - (2) At least one enclosed, covered structure to be used as a medical treatment center providing at least a total of 450 square feet with running water under pressure from an approved source;
 - (3) A list of medical supplies and equipment sufficient to support reasonably anticipated medical care requirements;
 - (4) Notification of all general public hospitals within 20 miles of the mass gathering location as to scheduled dates and anticipated attendance of the mass gathering;

- (5) The name and address of at least one licensed ambulance service agency to be responsible for providing emergency transportation, and a signed, notarized statement by an official of the agency accepting such responsibility submitted (15A NCAC 18A.1415);
- j. A water supply from an approved source shall be provided, along with an approved emergency the activity and camping areas at a rate of not more than 100 persons per toilet seat, with specific requirements regarding waste disposal methods, as well as cleaning and servicing of the toilets on a daily basis (15A NCAC 18A.1416);
- k. The provision of sanitary toilet facilities shall be provided at convenient and readily accessible locations properly distributed throughout the activity and camping areas at a rate of not more than 100 persons per toilet seat, and specific provisions are to be complied with regarding regular servicing, upkeep, and removal of toilets and human waste, as well as connections to sewerage systems (15A NCAC 18A.1417);
- l. Facilities shall be provided for all solid wastes to be collected and stored in leak-proof, nonabsorbent containers, and all solid wastes shall be removed daily or more often and disposed of in a community solid waste disposal facility or in a sanitary landfill to be constructed in the area, and approved receptacles having a maximum capacity of 32 gallons shall be provided at places conveniently located throughout the activity, camping, and parking areas, and at each food service facility for the deposition of solid wastes (15A NCAC 18A.1418);

- m. Sanitary food dispensing facilities shall be provided at accessible and convenient locations, shall be maintained in a sanitary condition, and perishable food items dispensed from such facilities shall be limited to pre-packaged items, such as wrapped sandwiches, prepared in commercial establishments under official sanitary supervision, and shall be dispensed in the unbroken packages; provided, that chicken, hamburgers, and frankfurters obtained from approved sources may be cooked and packaged at the site if all operations of preparation, cooking and packaging in unit packages for dispensing to individuals are done inside an approved structure or vehicle, in a sanitary manner, and otherwise in compliance with State Law (15A NCAC 18A.1419);
- n. There shall be no fly or mosquito-breeding places, rodent harborages, or undrained areas on the premises. Necessary measures shall be taken to control flies, mosquitoes, rodents, or other vermin (15A NCAC 18A.1420);
- o. Within one week after the end of the gathering, all sanitary landfills and any trenches or pits used for sewage and liquid waste disposal shall be covered with at least two feet of compacted earth material, the areas and immediate surrounding properties shall be cleaned of all litter and solid wastes attributable to the mass gathering, and any signs, litter, and solid wastes on roads leading from the areas and within one mile of the areas and which can be attributed to the mass gathering shall be removed vermin (15A NCAC 18A.1421);

- p. There shall be detailed plans for amplifying equipment, which shall be so located and operated as to limit the noise level at the perimeter of the site to no more than 70 decibels on the A scale of a sound level meter which meets the specifications of the American National Standards Institute (15A NCAC 18A.1422);
- q. There shall be detailed plans for lighting designed to illuminate the site (15A NCAC 18A.1423); and
- r. Signs shall be posted throughout the area showing the locations of toilet facilities, water supply outlets, solid waste receptacles, food stands, first aid facilities, and the command post. (15A NCAC 18A.1424).

35. Upon information and belief, Defendants are actively planning to hold a mass gathering, as that term is defined in §130A-252(a) of the North Carolina General Statutes.

36. Upon information and belief, Defendants completely failed to apply for the permit required by Article 8, Part 7 of Chapter 130A of the North Carolina General Statutes, including the rules promulgated thereunder, and found at 15A NCAC 18A.1404 through .1425.

37. Upon information and belief, Defendants failed to establish or implement any of the health and public safety plans, measures, and/or techniques required by Article 8, Part 7 of Chapter 130A of the North Carolina General Statutes, including the rules promulgated thereunder, and found at 15A NCAC 18A.1404 through .1425.

SECOND CLAIM FOR RELIEF – TEMPORARY RESTRAINING ORDER

38. The health, safety, and welfare of not only the person who will attend the Proposed Event, but also those persons who leave near its venue, along with law enforcement, EMS, and fire personnel, will be in imminent, immediate, irreparable jeopardy if the Proposed

Event goes forward February 19 through 21, 2016, inasmuch as the appropriate planning, permitting, and infrastructure contemplated by Article 8, Part 7 of Chapter 130A of the North Carolina General Statutes, including the rules promulgated thereunder, and found at 15A NCAC 18A.1404 through .1425 are not in place, and there is insufficient time to put such planning, permitting, and infrastructure in place to accommodate a mass gathering.


39. Immediate and irreparable damage will be incurred if Defendants go forward with the Proposed Event.

40. Upon information and belief, unless restrained, Defendants will continue to unlawfully go forward with the Proposed Event.

41. To avoid immediate and irreparable harm, Plaintiffs are entitled to a Temporary Restraining Order restraining Defendants from going forward with the Proposed Event.

42. Plaintiffs are empowered to prosecute this action for injunctive relief, irrespective of other remedies at law, in the Superior Court of the county where the violation is occurring, pursuant to §130A-18 of the North Carolina General Statutes.

AFFIDAVIT OF SAMANTHA WULLENWABER

I, Samantha Wullenwaber, having been duly sworn, depose and say that:

1. I am a citizen and resident of Johnston County, North Carolina. I am over the age of 18 years, and under no disability rendering me unable to swear to the following facts.
2. I am the Planning Director for the City of Dunn (hereinafter referred to as "Dunn"). I assumed this position on July 1, 2011.
3. On or about January 27, 2016 at 2:00 p.m., Jerry M. Hartman and his son met with officials from Dunn, including myself and the Fire Inspector, Anthony Haney, and the Chief Building Inspector, Steven King.
4. Mr. Hartman initially requested permission to hold a "fire show" on his property, then later stated that the proposed event would be an arts festival. Mr. Hartman then later stated that the proposed event would be a music festival, and then finally stated that the proposed event would be a three day arts and music festival with primitive camping, fire shows, vendors, alcohol, musicians, and the like.
5. I, along with her other colleagues in attendance at the meeting, unequivocally advised Mr. Hartman that such event would be in violation of Dunn's zoning ordinance, in that the parcel is currently zoned "industrial," and cannot be used to hold such commercial events.
6. At this January 27, 2016 meeting, I further advised Mr. Hartman that he could apply for his property to be rezoned to "commercial," and then further apply for a conditional use




permit for an event venue. Mr. Hartman responded that he did not wish to apply for rezoning, or for a conditional use permit.

7. In response to Mr. Hartman's statement that he did not wish to seek the proper zoning and use permits, I unequivocally advised him that his proposed event could not happen at all, no matter how big or small, due to not only the zoning issues herein referenced but also due to concerns over fire and building code violations that would most likely occur if the proposed event went forward.
8. Mr. Hartman's property is within the extra-territorial jurisdiction of Dunn, and thus enforcement of State fire and building codes is delegated to Dunn officials.
9. I heard nothing further from Mr. Hartman, and nothing further regarding this proposed event, until on or about February 5, 2016. On that day, I received a telephone call from Sharon Stevens, the Dunn Tourism Director, in which Ms. Stevens advised me that "a big festival" was set to occur in Dunn February 19 through 21, 2016.
10. When I questioned Ms. Stevens further, it became apparent to me that the event to which Ms. Stevens was referring was the proposed event I previously advised Mr. Hartman that he could not have.
11. I then found a Facebook page promoting the proposed event, and denominating it as the Candy Music and Arts Festival.
12. On the Facebook page, I saw comments stating that the City of Dunn "gave their blessing." This is not true. This is a misstatement of fact.
13. As Director of Planning and Zoning, and based upon my years of experience in this position, and in conjunction with speaking with law enforcement, building inspectors and the fire marshal, I have grave concerns for the health, safety and welfare of any persons attending this event.
14. Further affiant sayeth naught.

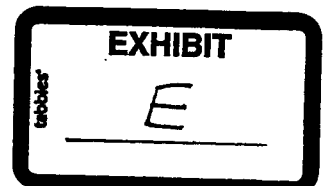
This weekend, the biggest party around is in the last place you'd think to look — on 15 overgrown acres on the outskirts of Dunn.

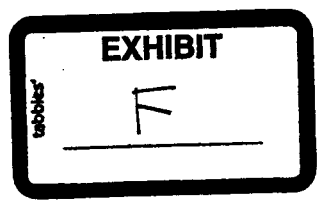

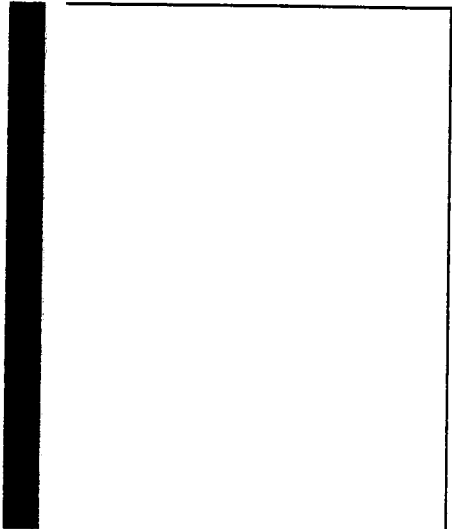

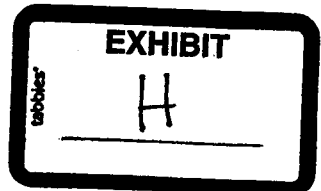
