A CONVICTION OF IMPAIRED DRIVING UNDER G.S. 20-138.1 (INCLUDING CONVICTIONS AT LEVELS ONE AND TWO) RESULTS IN A ONE-YEAR REVOCATION UNLESS:

- I. THE PERSON HAS BEEN CONVICTED OF ANOTHER OFFENSE INVOLVING IMPAIRED DRIVING THAT OCCURRED WITHIN THREE YEARS PRECEDING THE CURRENT OFFENSE (IN THAT CASE THE REVOCATION IS FOR FOUR YEARS, SEE G.S. 20-19(D));
- II. THE PERSON HAS TWO OR MORE PREVIOUS IMPAIRED
 DRIVING OFFENSES, ONE OF WHICH OCCURRED WITHIN THE
 FIVE YEARS IMMEDIATELY PRECEDING THE DATE OF THE
 CURRENT OFFENSE (IN THAT CASE THE REVOCATION IS
 PERMANENT, SEE G.S. 20-19(E)); OR
- III. THE PERSON IS SENTENCED AT AGGRAVATED LEVEL ONE (IN THAT CASE THE REVOCATION IS PERMANENT, SEE G.S. 20-19(E)).
