- ✓ Designees must have satisfactorily completed the following courses of instruction: **(Prelicensing appraisal courses R1, R2, R3, and G1 will be accepted in lieu of IAAO 101 if the applicant is certified as an appraiser or assessor by NCDOR or licensed or certified as an appraiser by the NCAB.)**
- ✓ Applicant must submit a signed statement from their supervisor verifying tenure of employment in the required position and pertinent job duties.

- ☐ Fundamentals of Real Property Appraisal (IAAO 101)
