## RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF THE COUNTY OF MONTGOMERY, NORTH CAROLINA ADOPTION OF HUMAN SERVICES FLEXIBILITY

**Whereas**, to promote efficiency and effectiveness in the administration of human services and to strengthen the local public health infrastructure by establishing a public health improvement incentive program and to ensure the provision of the ten essential public health services the North Carolina General Assembly passed in the 2011 session House Bill 438 amending NCGS 153A-77; and

**Whereas**, the amended NCGS 153A-77 authorizes the Board of County Commissioners to exercise its jurisdiction over commissions, boards, and agencies by assuming direct control of any activities theretofore conducted by or through those entities by the adoption of a resolution; and

**Whereas**, the amended NCGS 153A-77 requires the establishment of an advisory committee for public health consistent with NCGS 130A-35; and

**Whereas**, the amended NCGS 153A-77 consolidates human services by allowing supervision of health and social services directors under the county manager; and  
**Whereas**, the amended NCGS 153A-77 promotes the organizational efficiency and flexibility needed to serve the residents of the county; and

**Whereas**, the amended NCGS 153A-77 allows for the continuation of mental health services by regional partnerships;

**Now, therefore, be it resolved** that the Montgomery County Board of Commissioners dissolves existing county Boards of Health and Social Services, assuming direct control over both departments, and consolidates county supervision of health and social service directors under the county manager.
