Even though City Hall is closed, operations at the City of Asheville continue to function. There is now a temporary Bid Submittal Process which includes a drop box where Bids can be deposited by the posted bid deadline. This drop box belongs to the Water department for the drop off of water payments.

The Water Department payment drop box at <u>City County Plaza</u> is in the first roundabout in front of the Buncombe County Courthouse as you enter the plaza.

Temporary Bid Openings Process: Formal In-Person Public Bid Openings have been suspended. During this public health emergency, the public can attend the bid openings via a live YouTube Feed (see link below). The physical bid openings will be held in the first floor conference room since there is equipment there for the LIVE stream. There will be witnesses to affirm that all proposals remain sealed until the live Bid opening. The project managers should coordinate with Purchasing to ensure there is at least one person from Purchasing as well as one person from the department is scheduled to attend. Purchasing will prepare an agenda with the Bid name and # so the details of each bid opening session will be clear. Purchasing will be responsible for coordinating with Water Service to retrieve the bids from the drop box. If architects or engineers are required at the bid open then the department representative should be responsible for gaining them access into the building and advising Purchasing so they are added to the agenda list. These Bid openings will be conducted on Thursdays at 3pm where the Contract Managers and Purchasing staff will open the sealed bids via Youtube. Here is the link to view the bid openings.

- Water Customer Service (WCS) will handle the bids from the drop box and secure them until the bid opening.
- On Thursdays, Purchasing will assist WCS in retrieving the bids from the drop box.
- Courier packages are all being rerouted to Bingham Road. Staff there is logging
 the bids and a purchasing representative will be responsible for these per Legal's
 direction for time of pick up and delivery.
- Purchasing Staff and Project Managers will conduct the bid openings.
 (one representative from the engineering/architectural firm may be present)
