## IAAO CERTIFICATE OF EDUCATIONAL RECOGNITION

The IAAO is now offering a new professional credential, the Certificate of Educational Recognition. The certificate will be awarded to IAAO members who have completed IAAO Courses 1 and 2 and two elective courses since December 31, 1978.

The new certificate requires course credits only, while the CAE and RES designations require the writing of narrative appraisal reports. Attainment of the Certificate of Educational Recognition will hopefully encourage members to pursue the CAE or RES designation. Completion of the course requirements for the certificate satisfies the course requirements for the real property track to the CAE.

The Certificate of Educational Recognition is good for ten years from the date of the earliest of the four required courses. When the certificate expires, a member can qualify for a new certificate by completing an additional five-day IAAO course.

Professional Designation: Not only are these designations an indication of learned knowledge and meaningful industry experience, they also imply a dedication to excel. The financial and time commitments to achieve any industry professional designation are significant and not to be considered lightly. Knowledgeable employers seek--and justly reward--those professionals who have completed that career "degree." A mention of candidacy toward a designation is not relevant in a resume; however, a listing of the specific coursework, reports, and experience credits approved, etc., is meaningful to the employer reviewing a resume....

#### CAE : REQUIREMENTS

There are four "tracks" to the CAE designation: the real property appraisal report track, the mass track, appraisal the computerassisted valuation track, and the personal property appraisal report track. Regardless of the chosen track, the following general requirements must be met by the date of certification (requirements specific to the individual tracks follow the general requirements):

- 1. Candidacy in the CAE program.
- At least five years of appraisal experience in the assessment field.
- Within the preceding ten years, a passing grade on the examination for IAAO Course 1 (or on an equivalent examination).
- Within the preceding ten years, a passing grade on an elective course examination, preferably

- IAAO Course 3 or Course 301. (No elective course is required for the computer-assisted valuation track.)
- A passing grade on the comprehensive CAE examination. This examination is administered only after all other requirements have been met.
- 6. Submission to the Professional Admissions Committee of an affidavit attesting to employment, IAAO membership, and experience.

#### Real Property Appraisal Report Track

Candidates who elect the real property appraisal report track must also complete the following specific requirements:

- Within the preceding ten years, a passing grade on the examination for IAAO Course 2 (or on an equivalent examination).
- Acceptance by the Professional Admissions Committee of a complete demonstration appraisal report, using the recognized approaches to value, on a single-family residence.
- 3. Acceptance by the Professional Admissions Committee of a complete demonstration appraisal report, using the recognized approaches to value, on an income-producing improved property.

#### Mass Appraisal Track

Candidates who elect the mass appraisal track must also complete the following specific requirements:

- Within the preceding ten years, a passing grade on the examination for IAAO Course 2 (or on an equivalent examination).
- Acceptance by the Professional Admissions Committee of a complete demonstration appraisal report, using the recognized approaches to value, on a single-family residence.

- 3. Attendance at IAAO Course 302 and a passing grade on the examination. This course must be completed prior to sitting for the IAAO Case Study Examination on the Mass Appraisal of Income-Producing Property.
- A passing grade on the IAAO Case Study Examination on the Mass Appraisal of Income-Producing Property.

#### Computer-Assisted Valuation Track

Candidates who elect the computer-assisted valuation track must also complete the following specific requirements:

- 1. Within the preceding ten years, a passing grade on the examination for IAAO Course 2 (or on an equivalent examination).
- Within the preceding ten years, a passing grade on the examination for IAAO Course 303 (or on an equivalent examination).
- 3. Acceptance by the Professional Admissions Committee of a complete demonstration appraisal report, using the recognized approaches to value, on an income-producing improved property.
- 4. Attendance at IAAO Course 305 and a passing grade on the examination. This course must be completed prior to submitting the computer-assisted valuation report.
- 5. Acceptance by the Professional Admissions Committee of a report on the computer-assisted valuation of a group of single-family residential properties (the computer-assisted valuation report).

## Personal Property Appraisal Report

Candidates who elect the personal property appraisal report

track must also complete the following specific requirements:

- 1. Within the preceding ten years, a passing grade on the examination for IAAO Course 5 (or on an equivalent examination).
- Acceptance by the Professional Admissions Committee of a complete demonstration appraisal report, using the recognized approaches to value, on a retail, service, or manufacturing business.
- 3. Acceptance by the Professional Admissions Committee of a complete demonstration appraisal report, using the recognized approaches to value, on either a single-family residence or an income-producing improved property.

#### RES REQUIREMENTS

To qualify for the RES designation, the following requirements must be met on the date of certification:

- 1. Candidacy in the RES program.
- At least three years of appraisal experience in the assessment field.
- 3. Within the preceding ten years, a passing grade on the examination for the IAAO Course 1 (or on an equivalent examination).
- 4. Within the preceding ten years, a passing grade on either the examination for IAAO Course 2 or the examination for IAAO Course 301 (or on an equivalent examination).
- 5. Acceptance by the Professional Admissions Committee of a complete demonstration appraisal report, using the recognized approaches to value, on a single-family residence.

- 6. A passing grade on the comprehensive RES examination. This examination is administered only after all other requirements have been met.
- 7. Submission to the Professional Admissions Committee of an affidavit attesting to employment, IAAO membership, and experience.

#### CONSTITUTION OF THE NORTH CAROLINA CANDIDATES' CLUB

#### ARTICLE I

#### Name and Objectives

Section 1. The name of this organization shall be the North Carolina Candidates' Club.

Section 2. The objective of this club shall be to promote the International Association of Assessing Officers Professional Designation program in order to improve the standards of assessment procedure and practice throughout North Carolina.

#### ARTICLE II

#### Membership and Dues

Section 1. Regular Members. Governmental (State and Local) employees who are actively involved in Property Tax Assessment in North Carolina. Annual dues payable on or before the first annual meeting shall be \$10.00 per year.

Section 2. Subscribing Members. Persons not eligible as regular members who subscribe to the objectives of the club. Annual dues payable on or before the first annual meeting shall be \$20.00.

Section 3. Honorary Members. CAE's who have attained their designation through the North Carolina Candidates' Club or who have attained the CAE designation in the past who are residents of North Carolina.

Section 4. Voting Rights. Voting rights are reserved for regular members and subscribing members who are in good standing.

Section. Ethics. Every member of the club agrees to conduct himself or herself in a manner that shall reflect credit upon the profession of assessing; to protect that profession from any form of activity found to be unjust, unethical or detrimental to the public or to the profession; and to give strict adherence to the Code of Ethics which has been adopted by the North Carolina Association of Assessing Officers and the International Association for Assessing Officers.

Section 6. <u>Dues</u>. Members in good standing shall be those who have made timely payment of dues. Timely payment being dues paid on or before the first annual meeting.

#### ARTICLE III

#### Steering Committee

Section 1. <u>Selection</u>. At the first annual meeting, two (2) persons who are members in good standing, shall be elected for a three (3) year term from the regular and subscribing members. Total membership shall be six (6).

Section 2. Moderator. The steering committee shall elect a moderator for the purpose of: (a) calling steering committee meetings, (b) conducting the business for the steering committee, (c) reporting to the membership, (d) presiding at regular club meetings.

Section 3. <u>Secretary/Treasurer</u>. The steering committee shall elect a Secretary/Treasurer to: (a) serve as club secretary at all club meetings and steering committee meetings, (b) to handle all correspondence for club, (c) to handle all funds for club, (d) to preside in absence of moderator at club meetings and steering committee meetings.

#### ARTICLE IV

#### Meetings

Section 1. Meetings. The club shall hold two (2) annual meetings at the Institute of Government in Chapel Hill. Meetings shall be devoted to discussion of matters of interest pertaining to achieving a professional designation through the International Association of Assessing Officers Professional Admissions Program.

#### ARTICLE V

#### Amendments

Section 1. Amendments. This Constitution may be amended by a majority vote of regular and subscribing members in good standing, present and voting at the annual meetings.

#### ARTICLE VI

#### Fiscal Year

Section 1. Fiscal Year. The fiscal year of the club shall be from January 1 to December 31.
