The defendant has been charged with assault on a(n) [legislative] [executive] [court] officer with a deadly weapon.

For you to find the defendant guilty of this offense, the State must prove four things beyond a reasonable doubt:

First, that the defendant assaulted the victim by intentionally (and without justification or excuse) (describe assault).

Second, that the defendant used a deadly weapon. A deadly weapon is a weapon which is likely to cause death or serious bodily injury.

[(Name weapon) is a deadly weapon.] [In determining whether (name weapon) is a deadly weapon, you should consider the nature of (name weapon), (and) the manner in which it was used, (and the size and strength of the defendant as compared to the victim).] $^3$ 

If a definition of intent is required, see N.C.P.I.--Crim. 120.10.

Third, that the victim was a(n) [legislative] 4 [executive] 5 [court] officer. [(Name victim's title) is a(n) [legislative] [executive] [court] officer.]

And Fourth, that the defendant knew or had reasonable grounds to know that the victim was a(n) [legislative] [executive] [court] officer.

If you find from the evidence beyond a reasonable doubt that on or about the alleged date, the defendant assaulted the victim with a (name weapon) (and that (name weapon) was a deadly weapon), that the victim was a(n) [legislative] [executive] [court] officer, and that the defendant knew or had reasonable grounds to know that the victim was a(n) [legislative] [executive] [court] officer, (nothing else appearing) it would be your duty to return a verdict of guilty. If you do not so find or have a reasonable doubt as to one or more of these things, it would be your duty to return a verdict of not guilty.10
