237.45 PROVIDING FALSE INFORMATION IN ORDER TO OBTAIN A LICENSE TO OPERATE A BEACH BINGO GAME. MISDEMEANOR.

The defendant has been charged with providing false information in order to obtain a license to operate a beach bingo game.

For you to find the defendant guilty of this offense, the State must prove three things beyond a reasonable doubt:

<u>First</u>, that on or about the alleged date, the defendant submitted an application as prescribed by the State Bureau of Investigation in order to operate a beach bingo game<sup>1</sup> within the State of North Carolina.

<u>Second</u>, that the defendant provided false information<sup>2</sup> on [his] [her] application submitted to the State Bureau of Investigation<sup>3</sup> in order to obtain a license to operate a beach bingo game by (*describe the false information on the application*).

And Third, that the defendant did so knowingly.

If you find from the evidence beyond a reasonable doubt that on or about the alleged date, the defendant knowingly submitted an application as prescribed by the State Bureau of Investigation in order to operate a beach bingo game within the State of North Carolina, and that the defendant provided false information on [his] [her] application submitted to the State Bureau of Investigation by (describe the false information on the application), then it would be your duty to return a verdict of guilty. If you do not so find or have a reasonable doubt as to one or more of these things, it would be your duty to return a verdict of not guilty.

Stat. § 14-309.6(2) defines a "beach bingo game" as a specific game of chance played with individual cards having numbered squares ranging from one to 75, in which prizes are awarded on the basis of designated numbers on such cards conforming to a predetermined pattern of numbers (but shall not include "instant bingo" which is a game of chance played by the selection of one or more prepackaged cards, with winners determined by the appearance of a preselected designation on the card).
