[SELLING] [GIVING] A WEAPON TO A MINOR. G.S. 14-315. FELONY, MISDEMEANOR.

The defendant has been charged with [selling] [giving] a  $(name\ weapon)^2$  to a minor.

For you to find the defendant guilty of this offense, the State must prove two things beyond a reasonable doubt:

 $\underline{\text{First}}$ , that the defendant [sold] [gave] (describe weapon) to a person.

And Second, that the person was a minor under the age of 18 years of age.

If you find from the evidence beyond a reasonable doubt that on or about the alleged date the defendant [sold] [gave] (name weapon) to a minor, it would be your duty to return a verdict of guilty.<sup>3</sup> If you do not so find or have a reasonable doubt as to one or more of these things, it would be your duty to return a verdict of not guilty.

 $<sup>^{1}\</sup>mathrm{The}$  statute also forbids one to offer for sale or in any way transfer a weapon to a minor.

<sup>&</sup>lt;sup>2</sup>Handgun is defined in G.S. 14-269.7. Selling, offering for sale, giving, or in any way transferring a handgun to a minor is a Felony and results in a forfeiture of the proceeds of the sale.

Weapons "other than handguns" include the following: pistol cartridge, brass knuckles, bowie knife, dirk, shurikin, leaded cane, or slungshot. Selling, offering for sale, giving, or in any way transferring a weapon other than a handgun to a minor is a misdemeanor and results in a forfeiture of the proceeds of the sale.
