Rabies Control for People Bitten by Dogs or Cats

Rabies Control for People are Exposed to Rabies Vector Species (*bats, terrestrial carnivores*)

- 110. Identify (if possible) the biting animal and submit for rabies testing
- 111. Receive reports from physicians of persons bitten by animals capable of transmitting rabies
- 112. Provide rabies exposure risk assessments
- 113. Coordinate administration of rabies post exposure prophylaxis if necessary

Rabies Control for Domestic Animals that are Reasonably Suspected of Being Exposed to Rabies

- 114. Identify (if possible) the biting animal and submit for rabies testing
- 115. Order rabies booster, quarantine or euthanasia of the exposed animal

Rabies Vaccination

- 116. Coordinate at least one annual rabies vaccination clinic in the county for dogs, cats and ferrets

Rabies County Canvas
