Pre-Conference Workshop: Making Change: How Personal Preferences Show Up at Work

Walking Tour: Wilmington's Northern

**Riverfront Park: The Municipal Leadership Role** 

in Downtown Redevelopment

Registration required. Along the Cape Fear River, North Waterfront Park, previously a lumber yard mill and cargo weigh station for the Port of Wilmington, has been transformed into 6.6 acres of newly accessible, versatile, waterfront open-space as well as a 7,000-capacity performance venue. As a new cultural destination for the City of Wilmington, the site goes above and beyond a singular purpose as a concert venue. The design seeks to encourage stewardship activities and reflection upon the City's past with waterfront gardens that immerse visitors into the native riparian landscape, interpretive signage, and an interactive water fountain evoking a tidal spray.

The Park will provide an economic benefit to Wilmington by serving as the central amenity to the developing northern downtown district and positively impacting property values. Since the park is easily accessible to a nearby parkway and highway, it is projected to host major community events that should spur spin-off economic activity to downtown businesses.
