













# Direct Contracting G.S. 14-234(a)(1) Making or administering a contract If you're involved at any point in the contracting process, you're involved in "making or administering" the contract





#### **Direct Contracting Exceptions**


- Contracts with banks, savings and loans, public utilities

## Gifts and Favors from Contractors G.S. 133-32 Prohibited Giver: Contractor or vendor who is: 1. Past (within 1 year) 2. Current 3. Potential future = Class 1 misdemeanor, unless an exception applies


