Conflicts of Interest

- NCGA → Legislation to provide a general framework for COI management
- DHHS → guidance and training re: amended COI law; information repository re: COI management
- County → designate person(s) responsible

Recommendations: Collaboration

Inter-County Movement of Clients

- Transfers
- NCGA → Legislation re: adult guardianship
- DHHS → Guidance re: info sharing for transfers
- NCGA → Notice before appointed guardian (adult)
- DHHS → More use of technology to engage
- AOC → remote communication/participation with incarcerated parents and respondent parties

Recommendations: Collaboration

Inter-County Movement of Clients

- Studies
 - Process for determining residency
- Appointment/funding of publicly-funded guardians
- Portability of eligibility determinations and service authorizations

Recommendations: Collaboration

Information Sharing

- AOC → New IT system should allow DSS access
- NCGA → Require study of confidentiality laws
- DHHS → Prepare guidance and offer training on information sharing and confidentiality

Primary Recommendation

The legislature should not require counties to join together to create multicounty departments to administer social services programs

Other Recommendations Related to Regional Administration

Study all social services programs to determine whether changes in administration are appropriate

If NCGA mandates regional administration, it should legislate county financial contribution and reevaluate state supervisory role

Provide clear communication about reform
