NC's Extended Foster Care Program: Foster Care 18 to 21



What is Foster Care 18 to 21?



An opportunity for young adults, who age out of foster care at age 18, to voluntarily agree to continue receiving foster care services, while transitioning into adulthood

The purpose of Foster Care 18 to 21 is to:

- Assist young adults in transitioning into adulthood while moving towards greater independence
- Meet the developmental needs of young adults who have aged out of foster care
- Advocate for what young adults state they need
- Provide a young adult driven program that allows former foster youth the independence other young adults their age have such as:
 - 1. Developing meaningful adult relationships and supports
 - 2. Making their own decisions and learning from their mistakes
 - 3. Transitioning into adulthood with a cushion of support



Foster Care 18 to 21: The Benefits

- Increases opportunities for success and overall well-being
- Creates positive adult connections and a network of support in early adulthood
- Increase in high school graduates, and enrollment in post-secondary education among former foster youth
- Decrease in criminal activity and homelessness among former foster youth
- Experience independence while having a "safety net" to fall back on
- Ongoing support during the critical transition into self-sufficiency

Background and Legal Basis

- 2008 Fostering Connections to Success and Increasing Adoptions Act (H.R. 6893/P.L. 110-351) allows states to receive federal Title IV-E reimbursement for costs associated with supports for young adults to remain in foster care up to age 21.

- N.C.G.S. § 108A-48 extends the provision of foster care benefits to young adults between 18 years of age and up to 21 years of age.

Existing CARS Agreements:

- Existing CARS Agreements will continue to be honored until terminated.
- There will be no new CARS Agreements as of January 1, 2017.
- Young adults who terminate their CARS Agreements can later enter into Foster Care 18 to 21, as long as the program eligibility criteria is met.





Program Eligibility CriteriaFoster Care 18 to 21



- In order to receive Foster Care 18 to 21 benefits and services the young adult must meet at least one of the following criteria (N.C.G.S. 108A-48(c)):
 - 1. Enrolled in high school or a program leading to an equivalent credential; or
 - 2. Enrolled in an institution that provides postsecondary or vocational education; or
 - 3. Participating in a program or activity designed to promote or remove barriers to employment; or
 - 4. Employed for at least 80 hours per month; or
 - 5. Incapable of completing the educational or employment requirements due to a medical condition or a disability.
- The young adult must also:
 - Have been in foster care upon his/her 18th birthday; and
 - Be 18 years of age, but not yet 21 years of age;
 - Enter into a Voluntary Placement Agreement with a county child welfare agency and agree to abide by the provisions of the agreement; and
 - Agree to reside in an approved placement.

- All young adults receiving Foster Care 18 to 21 services are eligible to receive monthly foster care maintenance payments.
- These payments will be the standard board rate, and will include standardized rates for child placing agencies and residential foster facilities.
- Available funding: Federal Title IV-E funds and State Foster Home Funds (SFHF).
- County Child Welfare Agencies are held harmless from contributing 50% of the nonfederal share.
- Each entry into the program is considered a new foster care episode.
- Eligibility determinations must be completed upon every entry/reentry.
- Determinations are based solely on the young adult without regard to the family in which they were removed from as a minor, or relatives the young adult may be currently residing with.

Foster Care Maintenance Payments Foster Care 18 to 21

- Payments can be made to a licensed or unlicensed placement.
- Payments can be made directly to the young adult, a rental agency/landlord, or a relative/family friend.
- Maintenance payments can be used for: Room and Board/Rent, Food, Transportation Costs, Utilities, and other Living Expenses.
- Young adults receiving SSI/SSA, ETVs and NC Reach are still eligible for monthly foster care maintenance payments.



County Oversight of Placements

Foster Care 18 to 21

Transitional Living Plans:

- An individualized plan developed in partnership with the youth/young adult
- Plan documents goals, services, and independent living skills that will assist the young adult in transitioning into self-sufficiency

Transition Support Team (TST) Meetings:

- A team of supportive adults who assist the young adult in developing goals and identifying services
- Young adult driven

Monthly Contacts:

- Within a three month cycle, 2 out of 3 visits must be face-to-face
- Quarterly in-home assessments

Independent Living Skills:

 Housing, Education/Employment, Money Management, Meal Planning, Housekeeping, Transportation, Healthcare, etc.

Placement Options

Foster Care 18 to 21

A. FOSTER CARE HOME / FACILITY

- Family Foster Home
- Therapeutic Foster Home
- Group Home

B. COLLEGE / UNIVERSITY DORMITORY

- On-Campus Dormitories
- On-Campus Apartments
- College Co-Ops

C. SEMI-SUPERVISED INDEPENDENT LIVING ARRANGEMENT

- Shared Housing (Apartment, Townhome, House)
- Non-College Dormitory
- Host Home
- Extended Relative or Family Friend



Semi-supervised Independent Living Settings

Foster Care 18 to 21

- A non-licensed, least restrictive living arrangement with approval and ongoing oversight by a county child welfare agency.
- Young adults can live on their own, while still receiving support services to help them become independent and self-sufficient.
- Placements should be selected based on the young adult's best interest, and an individual assessment of his or her needs, goals, and personal preference.
- This type of placement is appropriate for young adults who are:
 - High-functioning
 - Responsible
 - Developmentally Sound



Semi-Supervised Independent Living Foster Care 18 to 21

Assessing the Young Adult's Readiness:

- Budgeting and Financial Management
- Tenant Responsibilities
- Daily Tasks
- Safety and Behavior

Assessing the Placement:

- Living Conditions
- Utilities
- Safety Hazards





Intercounty and Interstate

Foster Care 18 to 21

Young adults can be placed out-of-county or out-of-state for the purposes of Foster Care 18 to 21 services.

Intercounty Placements and Transfers:

- Young adults can contact the county child welfare agency in the county in which they were previously in foster care, OR the county in which they are currently residing, to initiate services.
- An Intercounty Agreement (addendum to VPA) must be completed at the time the young adult signs the Voluntary Placement Agreement.

Interstate Placements:

- ICPC regulations must be followed when placing young adults receiving Foster Care 18 to 21 services across state lines.
- Receiving states may or may not agree to provide supervision and services for this population.
- If the receiving state is unwilling to provide supervision and services through ICPC, the county child welfare agency is responsible for ensuring supervision and services are provided to the young adult.



Terminations and Re-Entries Foster Care 18 to 21

Foster Care 18 to 21 benefits and services must be terminated when:

- The young adult reaches 21 years of age;
- The young adult no longer meets eligibility criteria*;
- The young adult requests that services be terminated;
- The court has determined the young adult is not meeting the goals of the Transitional Living Plan and/or the young adult has violated the Voluntary Placement Agreement for Foster Care 18 to 21; or
- The young adult has been absent from his/her approved placement for more than 14 days without prior approval from the county department of social services.

Re-Entry into Foster Care 18 to 21 can occur if the young adult:

- is at least 18 years of age, but not yet 21 years of age;
- was in foster care upon turning 18 years of age;
- is meeting at least one of the eligibility requirements for the program;
- is willing to enter into a VPA for Foster Care 18 to 21 and abide by the provisions of the agreement; and
- is willing to reside in an approved placement.

Values and Principals of Foster Care 18 to 21

The success of the program depends on all those involved

- The following are the values and principles that should guide our work with young adults in Foster Care 18 to 21:
 - Ensure that all young adults establish and maintain permanent lifelong connections to caring and committed adults
 - Allow young adults to gain real life experiences with independence, and allow them to learn from their mistakes
 - Work in partnership with young adults to develop and reach independent living goals
 - Empower young adult to take ownership of planning and developing goals, while learning decision-making skills along the way
 - Be a safety net for young adults during their transition to selfsufficiency, so they can successfully live as independent adults in the community


