# **Unintended Consequences**

### **Executive Order 118 closed all in-door dining**

- Outdoor seating was exempt in this order
- As a result dining rooms were moved to parking lots, side walks, front lawns, anywhere they could set up a table...
- Was this allowed as "outdoor dining"....??
- Who could enforce removal of these seats?
- Some jurisdictions had code enforcement, planning & zoning get involved
