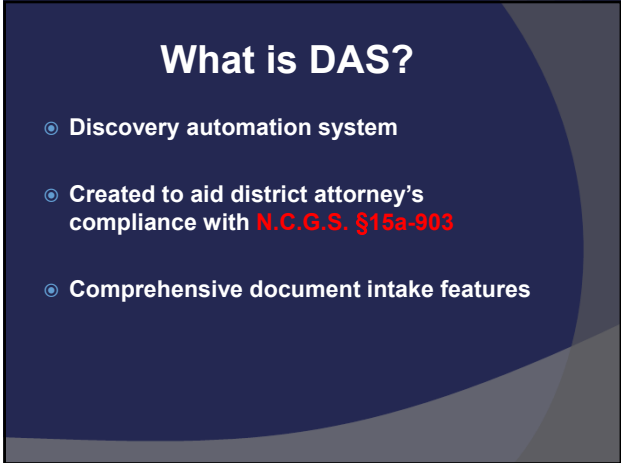
Online Services Cont'd:

- Ensure that the system is secure and fully integrated with existing NCAOC systems.

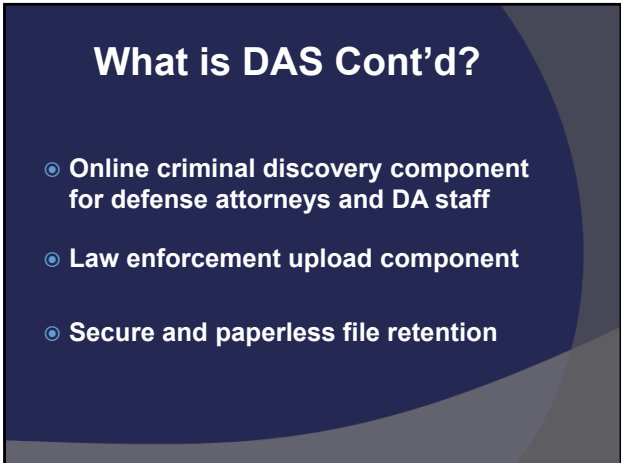
