FELONIOUS LARCENY--BY TRICK. FELONY. G.S. 14-70, 14-72.

The defendant has been charged with felonious larceny by trick.

For you to find the defendant guilty of this offense, the State must prove six things beyond a reasonable doubt:

First, that the defendant took property belonging to another person.

<u>Second</u>, that the defendant carried away<sup>2</sup> the property.

Third, that the defendant took and carried away the property from the victim by means of a false representation or trick.

Fourth, that at the time of the taking, the defendant intended to deprive the victim of its use permanently.<sup>3</sup>

<u>Fifth</u>, that the defendant knew he was not entitled to take the property.

And Sixth, that the property was worth more than \$1,000.4

If you find from the evidence beyond a reasonable doubt that on or about the alleged date, the defendant took and carried away another person's property by means of a false representation or trick, intending at that time to deprive the victim of its use permanently, and that the property was worth more than \$1000, it would be your duty to return a verdict of guilty of felonious larceny. If you do not so find or if you have a reasonable doubt as to one or more of these things, you will not return a verdict of guilty of felonious larceny<sup>5</sup> but must determine whether the defendant is guilty of non-felonious larceny. Non-felonious larceny differs from felonious larceny in that the property need not be worth more than \$1000.

If you find from the evidence beyond a reasonable doubt that on or about the alleged date, the defendant took and carried away another person's property by means of a false representation or trick and intending at that time to deprive the victim of its use permanently, it would be your duty to return a verdict of guilty of non-felonious larceny. If you do not so find or if you have a reasonable doubt as to one or more of these things, it would be your duty to return a verdict of not guilty.
