N.C.P.I. —CRIM. 221.16 TRANSPORTING FIVE OR MORE COUNTERFEIT INSTRUMENTS G.S. 14-119(b). Felony.

The defendant has been charged with transporting five (or more) counterfeit instruments.

For you to find the defendant guilty of this offense, the State must prove two things beyond a reasonable doubt:

First, that the defendant transported five (or more) counterfeit instruments. An instrument is any currency, bill, note, warrant, check, order or similar document issued by a financial institution or governmental unit. A counterfeit instrument is an instrument that purports to be genuine, but is not, because it has been falsely copied, reproduced, forged, manufactured, embossed, encoded, duplicated or altered.

And Second, that the defendant intended to [injure] [defraud] any [person]

[financial institution] [governmental unit].

If you find from the evidence beyond a reasonable doubt that on or about the alleged date the defendant transported five (or more) counterfeit instruments with the intent to [injure] [defraud] any [person] [financial institution] [governmental unit], it would be your duty to return a verdict of guilty. If you do not so find or have a reasonable doubt as to one or both of these things, it would be your duty to return a verdict of not guilty.<sup>3</sup>
