The defendant has been charged with [causing] [encouraging] [aiding] a minor to [carry] [possess] a weapon on educational property.⁴

For you to find the defendant guilty of this offense, the State must prove three things beyond a reasonable doubt:

<u>First</u>, that the defendant [caused] [encouraged] [aided] a person to $[carry]^5$ [possess]⁶ a (*describe weapon*).

<u>Second</u>, that the person was a minor under 18 years of age.

<u>And Third</u>, that the minor [carried] [possessed] that weapon on educational property.

If you find from the evidence beyond a reasonable doubt that on or about the alleged date, the defendant [caused] [encouraged] [aided] a person under 18 years of age to [carry] [possess] a (*describe weapon*), and that the minor [carried] [possessed] that weapon on educational property, it would be your duty to return a verdict of guilty. If you do not so find or
