If you find from the evidence beyond a reasonable doubt that on or about the alleged date that the defendant used an unmanned aircraft system within [a horizontal distance of 500 feet] [vertical distance of 250 feet] from a [local confinement facility] [state correctional facility] [federal correctional facility] and that the defendant [[delivered] [attempted to deliver]] [[a weapon] [contraband]] to a [local confinement] [state correctional facility] [federal correctional facility] it would be your duty to return a verdict of guilty. If you do not so find or have a reasonable doubt as to one or more of these things, it would be your duty to return a verdict of not guilty.
