270A.25 OPERATING VESSEL WHILE UNDER THE INFLUENCE OF AN IMPAIRING SUBSTANCE. MISDEMEANOR.

The defendant has been charged with operating a vessel while under the influence of an impairing substance.

For you to find the defendant guilty of this offense, the State must prove two things beyond a reasonable doubt:

 $\underline{\rm First},$ that the defendant was operating a vessel on the waters of this ${\rm State.}^1$

And Second, that the defendant did so

- (a) [while defendant was under the influence of an impairing substance.] (*Name substance involved*) is an impairing substance.² The defendant is under the influence of an impairing substance when the defendant has [taken] [consumed] a sufficient quantity of that impairing substance to cause the defendant to lose the normal control of the defendant's [bodily] [mental faculties] [both], to such an extent that there is an appreciable impairment of [either] [both of these faculties.³]];
- (b) [after having consumed sufficient alcohol that at any relevant time after the boating, the defendant had an alcohol concentration⁴ of [0.08] [more than 0.08] of alcohol [per 210 liters of breath] [per 100 milliliters of blood].⁵ A relevant time is any time after the boating that the [operator] still has in the body alcohol consumed [before] [during] the boating].⁶ The results of a chemical analysis are deemed sufficient evidence to prove a person's alcohol concentration.⁷

If you find from the evidence beyond a reasonable doubt that on or

about the alleged date the defendant was operating a vessel on the waters of this State and that the defendant

- (a) [was under the influence of an impairing substance.];
- (b) [after having consumed sufficient alcohol that at any relevant time after the boating, the defendant had an alcohol concentration of [0.08] [more than 0.08] of alcohol [per 210 liters of breath] [per 100 milliliters of blood],

then it would be your duty to return a verdict of guilty. If you do not so find or have a reasonable doubt as to one or more of these things, it would be your duty to return a verdict of not guilty.
